They have a Win NT network with Win 95 clients. ? They want to move the server with TAPI/SA from Win NT to a Win 2000 operating system and to use the old server for another purpose. ? Therefore, they have to remove SA from that server. ? After they removed SA and MTS, they had to remove Sybase Adaptive Server. ? They stopped Sybase services, put them in manual starting mode and tried to delete the Sybase folder but they couldn't delete them. ? An error appeared saying that those files are used by another application. What has to be done in order to delete the Sybase folder after stopping Sybase services?
